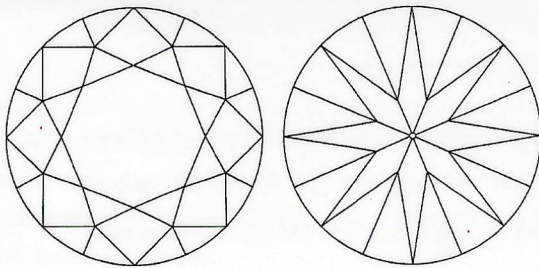

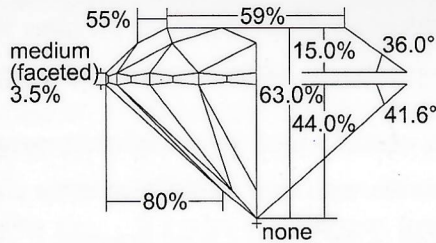

Profile to actual proportions



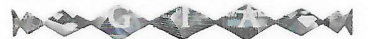
